

RIDER:

A. BASE BAND FEE INCLUDES: PERFORMANCE OF UP TO 3 HOURS, LOAD-IN, SETUP, AND TEAR-DOWN. ADDITIONAL PERFORMANCE TIME MAY BE REQUESTED AT THE TIME OF PERFORMANCE, AND WILL BE BILLED AT THE RATE OF \$75 PER MUSICIAN PER HOUR, BILLED IN HALF-HOUR INCREMENTS.

B. SALES OF CD'S/MERCHANDISE: MUSICIAN MAY OFFER TO SELL CD'S TO EVENT GUESTS FROM BANDSTAND/OR CONCESSIONS TABLE. IF EVENT INCLUDES SALE OF OTHER MERCHANDISE, MUSICIAN AND/OR AUTHORIZED AGENTS MAY ADD CD SALES TO AN ALREADY EXISTING CONCESSIONS AREA.

C. GUESTS OF BAND: UP TO ONE GUEST PER BAND MEMBER WILL BE ADMITTED TO EVENT

D. SOUND SYSTEM/LIGHTS: PURCHASER WILL PROVIDE NECESSARY SOUND REINFORCEMENT AND LIGHTING INCLUDING MINIMUM 12-CHANNEL MIXER, POWER AMPLIFIER, 2 MAIN SPEAKERS, 2 MONITOR SPEAKERS, MICROPHONES, STANDS, CABLES, AND ADDITIONAL EQUIPMENT AS NEEDED. MUSICIAN MAY CONTRACT THE SERVICES OF A COMPETENT SOUND ENGINEER WITH SPECIFIC EXPERIENCE AND SKILL IN LIVE SOUND REINFORCEMENT OF GROUPS THAT USE ACOUSTIC BRASS AND WOODWIND INSTRUMENTS. MR. PETERSEN IS AN ENDORSING ARTIST FOR AUDIX™ MICROPHONES; USE OF AUDIX-BRAND MICROPHONES IS PREFERRED WHENEVER POSSIBLE. MUSICIAN MAY REQUIRE A WALK-THROUGH OF THE PERFORMANCE LOCATION PRIOR TO EVENT IN ORDER TO ASSESS SOUND REINFORCEMENT NEEDS.

E. PIANO: PURCHASER AGREES TO PROVIDE A GOOD QUALITY, IN-TUNE, ACOUSTIC PIANO OR A FULL 88-KEY WEIGHTED DIGITAL PIANO; MUSICIAN AND/OR HIS REPRESENTATIVE(S) RESERVE THE RIGHT TO INSPECT PIANO PRIOR TO PERFORMANCE TO ENSURE ITS QUALITY. SUCH INSPECTION MAY TAKE PLACE WITH REASONABLE AMOUNT OF TIME PRIOR TO PERFORMANCE AS NEEDED TO MAKE OTHER ARRANGEMENTS SHOULD PIANO BE DEEMED UNACCEPTABLE.

F. GREEN ROOM/AMENITIES: PURCHASER WILL PROVIDE A SUITABLE BACKSTAGE ROOM FOR BAND MEMBERS TO CHANGE AND RELAX IN BEFORE AND AFTER THE PERFORMANCE, AND TO STORE INSTRUMENT CASES/ETC DURING THE PERFORMANCE. PURCHASER AGREES TO PROVIDE FREE-OF-CHARGE LIQUID REFRESHMENTS TO MUSICIAN AND BAND MEMBERS. UNLESS OTHERWISE SPECIFIED, THIS WILL INCLUDE AT MINIMUM A CONTINUOUS SUPPLY OF CHILLED WATER. PURCHASER IS ALSO ENCOURAGED TO PROVIDE HEALTHY SOFT DRINKS SUCH AS *VITAMIN WATER™* OR *SOBE™*. FOR EVENTS WHERE A MEAL IS SERVED TO GUESTS, BAND MEMBERS SHALL BE SERVED EQUIVALENT MEAL DURING THE BAND'S BREAK BETWEEN SETS OR AS TIMELY AS IS CONVEINIENT.

G. CONFIDENTIALITY: SOME DETAILS OF THIS AGREEMENT ARE CONFIDENTIAL. BOTH PARTIES AGREE THAT AT ALL TIMES AND NOTWITHSTANDING TERMINATION OR EXPIRATION OF THIS CONTRACT, NEITHER PARTY WILL DISCUSS OR DISCLOSE DETAILS OF THIS CONTRACT, INCLUDING (BUT NOT LIMITED TO) FINANCIAL INFORMATION, WITH ANY THIRD PARTY EXCEPT AUTHORIZED AGENT(S); PURCHASER MAY NOT UNDER ANY CIRCUMSTANCES DISCLOSE ANY TERMS CONTAINED IN THIS AGREEMENT EXCEPT FOR THE PURPOSE OF CONDUCTING BUSINESS UNDER THIS AGREEMENT. THE FINANCIAL INFORMATION IN THIS CONTRACT SHALL CONTINUE TO BE HELD CONFIDENTIAL REGARDLESS OF TERMINATION, EXPIRATION, OR ALTERATION OF ANY OTHER PART OF THIS AGREEMENT UNTIL TWO (2) YEARS FROM THE DATE OF THIS AGREEMENT.
